## 6. UPDATE FROM DORSET COUNCIL

- April 2025 Ward Councillors Report Sally Holland
- Impact of Spring Statement on Dorset Council
- The Spring Statement did not bring anything positive for councils. It means the importance of the increased efficiency drive over the next 3 years via the Transformation Process is even more important. DC will continue to invest in technology and changing the way it operates so it can best provide services to residents at lower costs.
- Increasing the supply of affordable homes
- Councillors at the People and Health Overview Committee have voted to support an increase in the supply of
  affordable homes in Dorset. This will be achieved through use of council-owned land and buildings and by
  leasing more homes across the county.
- A plan to supply 100 homes to be used for temporary accommodation for family and single households within 12 months will start first. The council will lease these homes for people needing emergency housing, resulting in minimal use of bed and breakfast accommodation in future.
- Councillors supported a proposal for a pilot using council land and buildings to provide homes for people with complex housing needs. More temporary accommodation and affordable housing, including social rent,

supported, accessible and adapted homes will be provided, and that residents and council services will benefit from the new provision

- Other recommendations were endorsed that will work toward setting up a pilot partnership and build affordable housing on council-owned land and to lease 400 homes a year over three years (1,200 in total) to Dorset residents on the housing register.
- The plans will help to reduce the numbers of people waiting on the housing register. Data will be used to determine the size, type and location of housing, including housing for key workers.
- This still needs to be passed by Dorset Council Cabinet.
- Dorset Bus Service Improvement Plan
- The funding received from the Government for Improving Bus Services (£3.3m) has now been allocated by DC. Unfortunately, none have been set aside for bus service improvement in the rural areas of West Dorset. It was a limited amount of funding. 2 other rural councillors and I have emailed the Portfolio Holder for Public Transport to raise our disappointment at missing out on improvements to bus services. There is a link below with more details.

- We've now reached the end of our Locality Grant and have completed a "End of Grant Report" that we've submitted to Locality. This shows that we spent £4,470.81 out of our grant of £5,342. We now need to wait for Locality to advise that they're content with our submission before we can ask the PC to return the unspent funding of £871.19. Sally has shared the end-of-grant report with John.
- Housing Needs Survey
  - You'll recall our earlier discussions with Jacqui Cuff about the Housing Needs Survey. Paul has followed this through and we've now had a more recent update from Jacqui. Paul raised a number of issues with her about this, including the point that John raised last time about the statistics. We envisage her updating her report to then share with the PC. She would very much like to attend the PC meeting of 6th May to address any points that you may have before the final version is published.
- Community Survey
  - As you'll be aware from my note of 13th March, we've postponed our Survey for a few months. This reflects the discussions we've had with our consultant and our Link Officer in Dorset Council, Philip Reese, who we met on 11th March. We believe that we will get more out of the Survey by further consideration of the evidence in the main areas of the plan as well as taking account of the results of the Dorset Housing Needs Survey. One likely change is to take advantage of the Survey to explore interest from the community in making land available for housing, employment or environmental use.
  - One other point on community interactions, this time on Identification of Non-Heritage Assets which you'll recall I raised at your last meeting. We're grateful to the Councillors who provided feed-back on our draft letter to residents regarding Non-Heritage Assets. We have raised the Councillors' points with our consultant and also are looking at linking this with other potential communications so that we minimise the number of requests. I'll advise the PC once the position is clearer.
- Upcoming Activities
  - O Given that we won't be able to apply for the final tranche of grant funding for a couple of months, we're focussing on things that don't need input from our consultant. Most of our work over this time is looking at drafting the Plan. Initially, we'll review the draft Topic papers so that we can consider potential policies in the Plan and hence identify questions for the community survey where we need further evidence. We're also hoping to undertake a Youth event that will help us get their views and help us design the survey to go to the youngsters. We'll also be supporting the Puncknowle Party at the Crown on 5th May.
